

## Overview

TEA suggests that school systems / local education agencies (LEAs) develop and conduct stakeholder surveys to collect feedback on both their experience with remote learning this spring, and their needs and concerns heading into the new school year.

On the following pages, tables are organized by stakeholder group and include a range of questions that may be of interest to a school system; these are designed to serve as question banks so that school systems can select and modify questions as they see fit. Question are included for the following stakeholder groups:

- Families / students
- Educators
- Central Office / Administrative Staff

In addition, TEA has provided example surveys that can serve as an additional resource for school systems:

## How to use this resource

1	Review this document and determine which sample questions are most relevant to your local context.
2	Using the most relevant questions to your local context, develop a survey using the survey instrument your LEA usually uses.
3	Administer the survey, as soon as possible.
4	Collect and analyze the data. Identify trends across the district and by campus or feeder pattern. Use this information to inform the set of learning options most relevant for your community.
5	Administer a second survey, two to three weeks before school begins. We recommend the second survey consist of a more limited set of questions (those highlighted in yellow in the table below).
6	Use the results of the second survey to inform adjustments to your plans.
