## ALREADY RETIRED: **Annual Membership**

Effective 21-22

**One-year membership in TSTA-R/NEA-R after retirement. Annual dues payable each year by September 1 to maintain membership.**

- CHOOSE ONE:**  TSTA/NEA ESP member at retirement (\$55)\*  TSTA/NEA Certified member at retirement (\$69)  
 Not a TSTA/NEA member at retirement but otherwise qualify for membership (\$69)

### PAYMENT OPTIONS (please check one):

- Dues paid in full (circle one) : **CHECK** (enclosed) **CREDIT/DEBIT CARD** (see card info or please call me)
- Bank Draft: **I am joining prior to Dec. 1**, and wish to pay my annual dues in full on an automatic, annual basis via bank draft. My voided check is enclosed. **NOTE:** Your payment will be deducted each year on Dec. 7 (or the first business day thereafter if the 7<sup>th</sup> falls on a weekend or holiday).

*\*You must qualify to receive this discount. If you were not a TSTA/NEA ESP member at the time of retirement, the full \$69 must be paid in order to activate your membership. Date of Retirement (see above) is required.*

## ALREADY RETIRED: **Retired Lifetime Membership**

**Lifetime membership in TSTA-R/NEA-R after retirement. One-time dues amount paid in full or in monthly installments. No yearly dues thereafter (except for region or local dues if applicable).**

- CHOOSE ONE:**  TSTA/NEA ESP member at retirement (\$430)\*  TSTA/NEA Certified member at retirement (\$550)  
 Not a TSTA/NEA member at retirement but otherwise qualify for membership (\$550)

### PAYMENT OPTIONS (please check one):

- Dues paid in full (circle one) : **CHECK** (enclosed) **CREDIT/DEBIT CARD** (see card info or please call me)
- Monthly installments via Bank Draft. My voided check is enclosed. **NOTE:** Your payment will be divided into a maximum of 10 equal installments, depending on when you enroll during the membership year. Deductions are made from October to July.
- Monthly installments via Credit or Debit Card. **NOTE:** Your payment will be divided into a maximum of 11 equal installments, depending on when you enroll during the membership year. Deductions are made from September to July.

*\*You must qualify to receive this discount. If you were not a TSTA/NEA ESP member at the time of retirement, the full \$550 must be paid in order to activate your membership. Date of retirement (see above) is required.*
